**Eligibility Criteria for Non-official Member of Appellate Tribunal**

A person to be selected as Non-official Member of the Maintenance Tribunal-

1. Should be not less than 35 years of age or more than 65 years of age.
2. Should possess a post Graduate Degree from a recognized University.
3. Should be a person of ability, Integrity and Standing and should have adequate knowledge and Experience of at least 10 years of working with an organization engaged in the welfare of Senior Citizens in the areas of Health, Woman Empowerment and Social Welfare.
4. Should be a Resident of the National Capital Territory of Delhi for not less than three years.

**Terms & Conditions**

1. The non-official Member shall be paid an honorarium as decided by the Government from time to time.
2. The tenure of the non-official member shall be for a period of three years from the date of joining the office or up to age of 65 years, whichever is earlier.
3. The state Government has the power to terminate the services of any Non-official member at any point of time in accordance with the provisions of the Maintenance and Welfare of Parents and Senior Citizens Act. 2007 and the Rules framed there under.
4. Should be a Resident of the National Capital Territory of Delhi for not less than three years.

**No person shall be considered for the selection as Non-official Member if he/she**

1. Has a previous conviction record.
2. Has been involved in any immoral Act.
3. Has been removed or dismissed from the service of the Government/PSUs/Corporate Body
4. Does not fulfill the age qualification and experience criteria prescribed in the Rules framed under the Act.

### **Eligibility Criteria for Non-official Member of Appellate Tribunal**

1. Should be not less than 50 years of age or more than 65 years of age;
2. Should possess a post Graduate Degree in Social Work/ Sociology/ Anthology/ Gerontology from a recognized university;
3. Should be a person of ability, integrity and standing and should have adequate knowledge and experience of at least 15 years of working with an organization engaged in the welfare of senior citizens in the areas of health, woman, empowerment and social welfare;
4. Should be a resident of National Capital Territory of Delhi for not less than three years;

### **Terms & Conditions**

1. The non-official Member shall be paid an honorarium as decided by the Government from time to time.
2. The tenure of the non-official member shall be for a period of three years from the date of joining the office or up to age of 65 years, whichever is earlier.
3. The state Government has the power to terminate the services of any Non-official member at any point of time in accordance with the provisions of the Maintenance and Welfare of Parents and Senior Citizens Act, 2007 and the Rules framed there under.
4. Should be a Resident of the National Capital Territory of Delhi for not less than three years.

### **No person shall be considered for the selection as Non-official Member if he/she**

1. Has a previous conviction record.
2. Has been involved in any immoral Act.
3. Has been removed or dismissed from the service of the Government/PSUs/Corporate Body
4. Does not fulfill the age qualification and experience criteria prescribed in the Rules framed under the Act.
