I am directed to convey the administrative approval and expenditure sanction of the Competent Authority, Department of Social Welfare, GNCT Delhi amounting to **Rs. 43,47,570/- (Rupees Forty Three Lakh Forty Seven Thousands Five Hundred Seventy only)** in respect of the estimate received from PWD for carrying out miscellaneous civil repair work at Hostel for College Going Blind Student at Sewa Kutir Complex, Kingsway Camp, subject to compliance of codal formalities, GFR, 2017.

The aforesaid estimate was received from PWD M 323 as per requisition made by the department vide letter No. F1(Sanction) CB/Hostel.2023-24/47 dtd 24/05/2023. The competent authority has restricted the A/A & E/S for carrying out the following works mentioned in the requisition for Civil Works only.

1. The gate at the ground floor, near washroom may be closed in purview of the safety of the Visually Impaired students.
2. Washrooms at the ground section, which are non-functional may be made functional.
3. In Kitchen Section, there are three key observations as
 - a) The Dough Kneader Machine (Aatta Guthne wali Machine) may be installed.
 - b) The Roti Maker machine is also required
 - c) The renovation of Kitchen section is required
 - d) Maintenance/plaster of the Wall of Dining area.
 - e) The net in the windows in the kitchen section to prevent Mosquito and other insects.
4. The plaster of the corridor is required.
5. The repair work of grills on first floor.
6. Few Water tanks to be covered with hard and safety Nets.

7. To remove the problem of Sewerage Blockage is also required to be done.

The sanction is further subject to the condition that the rates and other charges should not exceed the prescribed rate of CPWA Manual. PWD will be responsible for the quality of work and its completion on time apart from fulfillment of due procedure. **PWD is also required to submit a utilization/completion certificate after completion of the said works under reference.**

The expenditure is debited to the Major Head 4235-02-800-90-00-72 (provision of additional facilities in the existing building of Department of Social Welfare) for the Financial Year 2023-24 under Demand No. 11 Capital Head Scheme (PWD).
