

Reference this office Order No.F.44(51)/2023/DSW/Estt/Admn/19294-19305 dated 30.01.2024 wherein the pay scale of Cook was revised to Rs. 3050-45900 w.e.f. 01.01.1996 as per 5th CPC and subsequent corresponding pay scale w.e.f. 01.01.2006 on the recommendation of 6th CPC report with all consequential benefits including those in ACP and MACP Schemes. Further, all HOOs/DDOs of the Department were directed to comply the order.

In between, an order dated 07.03.2024 has been passed by Hon'ble High Court, Delhi in the matter of Nanda Ballabh vs Naresh Kumar & Ors. Cont Cas(C) 799/2023 (copy enclosed) giving direction that "last opportunity of six weeks is granted to the respondent to do the needful. It is made clear that in case the requisite amounts are not released to the petitioner within a period of six weeks, the concerned officer shall be present in Court on the next date of hearing" (copy enclosed).

Therefore, the all the HOOs/DDOs of Department of Social Welfare are hereby directed to ensure payment of arrears to the Cooks immediately and furnish a report regarding this to the Administration Branch, H.Q, DSW.
