Sir/madam,

I am directed to refer to this office letter of even no. dated 28.02.2024 wherein letter No.14016/13/2023-UTS-II dated 05.01.2024 (copy enclosed) and even number dated 12.01.2024 (copy enclosed) received from MHA along with prepared lists (**Annexure - A- General**), (**Annexure-B-SC/ST**) & (**Annexure-C-PwBD**) of cadre officers who are included in the zone of consideration for induction into Entry Grade of DANICS against the vacancies pertaining to the year 2019-2024, were forwarded to the Departments concerned to provide the requisite documents and undertaking of the officer concerned for willingness & non-willingness for onward transmission to MHA, GoI.

However, this office has received the requisite documents and undertakings of the officers from some of the Departments. This poor response will led to delay in the aforesaid induction process as MHA, GoI vide reminder letter dated 28.02.2024(Copy Enclosed) has requested to expedite the same.

Accordingly, I am again directed to request you to provide the requisite documents and undertaking of the cadre officers (including officers under suspension), at the earliest, for onward transmission to MHA,GoI as already conveyed by this office even letter no. dated 28.02.2024.

Further, a revised list of Annexure-C consisting of eligible PwBDs officer (as per available seniority list) under consideration zone as directed by MHA, GoI is annexed herewith for reference of the departments concerned to provide the requisite documents and undertaking of listed officers. Besides the requisite documents and undertaking of these officers (PwBDs) the following **additional information/documents** is also required from the department concerned to facilitate the MHA,GoI for the induction process in respect of such officers (PwBDs) in terms of the existing guidelines of DoPT:

(A) Blindness and low vision

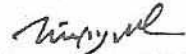

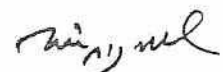

I am directed to refer to this Ministry's letter of even number dated 05.01.2024 and 12.01.2024 (copies enclosed) vide which the UT Administrations were requested to provide the requisite documents of the eligible officers of feeder grades for promotion/induction into the Entry Grade of DANICS against vacancy years 2019-2024. The following documents in respect of 400 officers in the normal zone of consideration and 800 officers for the extended zone of consideration for SCs/STs & PwBDs, as per seniority, were called:

- (i) Certified copy of seniority list of officers of feeder cadre of DANICS.
- (ii) Integrity Certificate/Vigilance clearance Certificate.
- (iii) Major/Minor penalty statement for last 10 years.
- (iv) Certificate to the effect that none of the ACRs/APARs of the officers is below benchmark, or if there is any below benchmark ACR/APAR, a certificate that the same has been communicated to the officer concerned.
- (v) Last 05 years' APARs (till year 2021-22). If last 05 years' APARs are not available, then, any available APARs as per DoPT's guidelines. If no APAR is available, a non-availability certificate shall be given in this regard.

2. It was also mentioned that the officers who are not willing to avail promotion may be allowed to opt-out and equal number of officers, below such officers in the seniority may be included in the zone of consideration.

3. The requisite information from any of the UT Segments concerned, is still awaited in this Ministry.

4. Therefore, it is again requested that the required information in respect of the feeder grade officers of DANICS, may be gathered and forwarded to this Ministry, at the earliest and latest by 08.03.2024.
