

The Additional Chief Secretary (GAD), Govt. of NCT of Delhi has allowed to conduct trials for selecting probable players of Wrestling and Swimming teams of Govt. of NCT of Delhi for participation in All India Civil Services Tournaments for the year 2024-25 as per the below schedule.


Further, it is also requested that all the officers/officials appointed under Sports Quota and presently working in your department may be directed to report for trial, for the game/event on the basis of which he /she was appointed in Govt. Service.

The trials shall be made strictly on the basis of instructions issued by the Central Civil Services and Sports Board, Government of India. As per the existing instructions, the following categories of employees are not eligible for participation;

- Employees of Autonomous bodies/Undertaking/Public Sector Banks even though administratively controlled by the Central Ministries.*
- In case of Deputation - The status of the Organisation in which the persons is working on deputation or otherwise is to be taken into account for deciding the eligibility.*

One officer/official will be selected as probable player in One Game only. On selection as probable player, he/she is required to submit the permission of the concerned Head of Department/competent authority for participation in the practice camp. This permission performa/letter will be required to be submitted within 10 working days of the issuance of selection order, failing which next player in the merit will be considered for selection as probable player. The said performa is also available on the official website of this department.

All Head of Departments, Govt. of NCT of Delhi are requested to circulate this trial schedule among all the officers/officials working in their departments. Interested officers/officials may also be allowed to report for trials at the venue as per schedule.
