ORDER

The approval of the Competent Authority i.e. Hon'ble Lt. Governor of NCT of Delhi vide Diary No. 41667 Dated 02.02.2024 is hereby conveyed for payment of allowances i.e. House Rent Allowance (HRA) and Travel Allowance (T.A.) to the contractual Welfare Officers which are admissible to regularly appointed Welfare Officers in the Department of Social Welfare, GNCTD.

The arrear shall be worked out for the respective contractual Welfare Officers (petitioners) from the date of filing of OA No. 2050/2014 titled Shashank Singh Tomar & Ors. Vs. GNCTD i.e. 10/06/2014 and OA No. 2110/2014 titled Siraj Ahmed Khan & Ors. Vs. GNCTD i.e. 25/06/2014.

The contractual Welfare Officers who are not petitioners in either of the above referred OAs and presently engaged in this Department, are to be paid the allowances i.e. HRA and TA which are admissible to regular Welfare Officers of this Department with immediate effect i.e. from the date of issuance of this order.

The expenditure involved on this account for payment of arrears w.e.f. 10/06/2014 and 25/06/2014 would be debit able to the concerned Head of Account of the respective DDO from where these contractual Welfare Officers are drawing salary which shall be released upon verification of the credentials of the incumbents as per Recruitment Rules for the post of Welfare Officers.

The pay and allowance being paid to the contractual Welfare Officers as applicable to regularly appointed Welfare Officers are in compliance of the order/judgment dated 21/04/2015 passed by Hon'ble Central Administrative Tribunal in OA No. 2050/2014 titled "Shashank Singh Tomar & Ors. Vs. GNCTD" and order dated 20/04/2014 passed by Hon'ble Central Administrative Tribunal in OA No. 2110/2014 titled "Siraj Ahmed Khan & Ors. Vs. GNCTD" respectively."

The contractual Welfare Officers shall not be entitled to any increment or promotion or regularization, and shall get pay at the minimum of the pay scale of regular Welfare Officers only.
