### Eligibility

- 1. Female unmarried totally blind students, who are bonafide residents of Delhi (Partially blind are not eligible).
- Maximum age up to 25 years.
- 3. Passed Senior Secondary (10+2) examination from CBSE or other recognized Board/passed B.A examination from University in Delhi.
- 4. Blind daughters of Govt./Defence employees posted outside Delhi may also be considered, subject to availability of seats.
- 5. Students of correspondence/evening colleges, and those who have passed M.A. and pursuing M.Phil., Ph.D., B.Ed., LLB, or other PG/Professional courses are not eligible.

#### Admission Procedure

- Apply in prescribed form (available at <a href="https://socialwelfare.delhi.gov.in">https://socialwelfare.delhi.gov.in</a>) with required documents.
- · Applicants will be interviewed by the Admission Committee and the decision of the Committee shall be final.
- Selected candidates must deposit ₹500 refundable caution money or submit a surety bond of equivalent amount.
- Admission/re-admission is not a matter of right.
- No admission shall be made during the mid academic session/year.

Facilities: Fooding & Bedding article as per Manual of Department of Social Welfare.

Note: Hostellers are required to apply for re-admission every year at the commencement of the academic session, subject to the hosteller following the rules and regulations of the hostel

Note: Students must apply for admission within 30 days of publication of admission notice on website.
