ADMISSION NOTICE: ACADEMIC YEAR 2026-27

Sub: Regarding Admission/Readmission for Hostel for College Going Blind Students (HCGBS), Kanti Nagar for the Academic Year 2026-27.

This is to inform all eligible students that the Hostel for College Going Blind Students (HCGBS) is now accepting applications for the Academic Year 2026-27.

I. Admission for New Applicants:

Applications are invited from fully blind Male students of Bonafide resident of Delhi (UT of Delhi) upto the age of 25 years who meet the following criteria:

- I. Passed Senior Secondary Examination from CBSE or any other equivalent Board or Passed B.A. Examination from a University in Delhi and are currently studying in affiliated colleges of the University of Delhi or other universities in Delhi.
- II. Have applied for accommodation in their respective college/university hostel but were unable to secure a place.
- III. Priority in admission shall be accorded to students who have passed out from Government Senior Secondary School for Blind Boys Sewa Kutir (Directorate of Education) as per Hon'ble High Court of Delhi orders dated 12.07.2023 in W.P.(C) 8210/2018 and 23.01.2024 in W.P.(C) 8210/2018.

2. Readmission for Existing Residents:

The readmission process for current residents of HCGBS wishing to continue their stay for the 2026-27 academic year has also commenced. Eligible students must apply for readmission.

3. Application Procedure for All Candidates:

Interested and eligible students must obtain the prescribed application form from the HCGBS office. The completed form, duly signed and accompanied by all requisite documents, must be submitted to the HCGBS Administrative Office.

4. Deadline for Submission:

The final date for the receipt of all completed applications is 5th August 2026, by 5:00 PM. No applications will be accepted after this deadline.
