This is with reference to your letter bearing No. 23(22)/N.E.D/PWD/2025-26/843 dt. 26/06/2025 and letter bearing No. F.No.(Misc.)/NCHB/DSW/2025-26 dt.14.07.2025 received from the concerned Superintendent, Atal Asha Home on the subject cited above.

It is to inform that A/A & E/S dt. 29.05.2025 of Rs. 8,88,98,994/- was issued for civil and electrical renovation/retrofitting works at Atal Asha Home (Nursing College and Hostel Buildings), PUHC Complex, Narela, Delhi - 40 from M.H. 4235-02-101-80-00-72 (i.e. Home for Mentally Challenged Persons - Building and Structure) under Demand No. 08 from the CFY 2025-26, which also includes A/A and E/S of Rs. 4,66,41,159/- for electrical works at the said Institution.

In this regard, Administrative Approval of the competent authority i.e. Director, SW/HoD of Rs. 73,44,345 (Rupees Seventy Three Lakhs Forty Four Thousands Three Hundred Forty Five only) is hereby conveyed for electrical renovation/retrofitting works at Atal Asha Home (Nursing College and Hostel Buildings), PUHC Complex, Narela, Delhi - 40 subject to the compliance of codal formalities, GFR 2017, etc, which will be taken up from the earlier aforesaid A/A & E/S dt. dt. 29.05.2025 of Rs. 8,88,98,994/- and also no separate expenditure sanction will be issued for the said Rs. 73,44,345/-.

The sanction is further subject to the condition that the rates and other charges should not exceed the prescribed rate of CPWA Manual and other relevant documents/orders. PWD will be responsible for the quality of work and its completion on time apart from fulfillment of due procedure. PWD is also required to submit a utilization-cum-completion certificate after completion of the said works.
