Sub: Visit of Asha Jyoti, Home for Mentally Challenged Persons (Female Adult), Nirmal Chhaya Complex, Hari Nagar by Hon'ble Minister on 13.08.2025.

Hon'ble Minister for Social Welfare visited the Asha Jyoti, Home for Mentally Challenged Persons (Female Adult), Nirmal Chhaya Complex, Hari Nagar. Deputy Director (Estate), DSW was also present during the visit. The following observations were made during the visit:-

- 1. Maintaining a clean and hygienic environment in residential complex is crucial for the health and well-being of the inmates. This includes addressing general cleanliness including weeding works by Horticulture Wing of PWD and effective pest control measures, timely condemnation of obsolete and old items etc.
- **2.** The complex requires immediate maintenance and repair works for safety of inmates on priority.
- 3. Implementation of biometric attendance for staff/officers.

Further, Hon'ble Minister has desired that all Homes / institutions of Department of Social Welfare should be visited by the senior officers of the Department once a week and a report along with photographs may be submitted to this office.

Moreover, inspection reports as per DSW order dated 01.07.2025 may be provided to this office immediately.
