MINUTES OF GIA COMMITTEE MEETING

A Meeting was held on 21/10/2025 at 11:00 A.M. under the Chairpersonship of Secretary, Department of Social Welfare (DSW) in her chamber at Department of Social Welfare 7th Floor, MSO Building, I.P. Estate, New Delhi-110002 regarding long pending Grant-In-Aid to various Non-governmental Organizations (NGOs) under Delhi Grants Rules, 2008 for the F.Y. 2023-24 & F.Y. 2024-25.

It was apprised that the constitution of GIA Committee as per Delhi Grant Rules, 2008 is as under: -

However, at present there is no Joint Director, DSW posted in Department of Social Welfare, GNCTD. In response to the meeting notice dated 14/10/2025, representatives of District Offices (North, West, South-West, South and New Delhi) were also present in the meeting on 21/10/2025. (a copy of attendance sheet is enclosed at page no. 353).

The Secretary, Social Welfare, expressed displeasure towards for the late submission of Grant-In-Aid related files to the VAC Branch after due inspection. Further it was also directed that the concerned District Social Welfare Officers shall submit the files after due inspection as per the guidelines within time prescribed so that the cases may be processed in the same Financial Year i.e. by the end of November.

The chair was apprised that all the inspection reports received from all the District Officers were duly scrutinised by Voluntary Action Cell Officers. It was apprised that calculation of grant in aid as per "Base Guidelines for scrutinizing the GIA proposals under Delhi Grant Rules, 2008" have been duly checked and found in order/examined by Senior Accounts Officer, Department of Social Welfare, GNCTD taking into account the norms as well as Base Guidelines as per Delhi Grant Rules, 2008 for under mentioned NGOs.

The Chair directed that the processing of the current grant-in-aid proposals be also expedited after their presentation in the GIA Committee meeting, so that the whole cycle doesn't unnecessarily lag behind causing distress to genuine institutions.
