MINUTES OF GIA COMMITTEE MEETING

A Meeting of the Grant-In-Aid (GIA) Committee was held on 23/01/2026 at 4:00 P.M. under the Chairpersonship of Director, Department of Social Welfare (DSW) in his chamber at Department of Social Welfare 7th Floor, MSO Building, I.P. Estate, New Delhi-110002 to consider the release of Grant-In-Aid to various Non-governmental Organisations (NGOs) under Delhi Grants Rules, 2008 for the financial year 2025-26. All the inspection reports received from all the District Officers were duly scrutinised by Voluntary Action Cell Officers. The calculation of grant in aid as per "Base Guidelines for scrutinizing the GIA proposals under Delhi Grant Rules, 2008" have been duly checked/corrected and found in order by Senior Accounts Officer, Department of Social Welfare, GNCTD taking into account the norms as well as Base Guidelines as per Delhi Grant Rules, 2008 for under mentioned NGOs.
