Governor of National Capital Territory of Delhi is pleased to further amend the "Delhi Maintenance and Welfare of Parents and Senior Citizens Rules, 2009", issued vide Notification No.F.JD(A) WO Sr.Ctz.Maint. Bill DSW 2005-06/5547-70dated 30.06.09 as following, namely:-

- 1. Short title and commencements (i) These rules may be called the Delhi Maintenance and Welfare of Parents and Senior Citizens (Amendment) Rules. 2010.
 - (ii) They shall come into force on the date of their publication in the Delhi Gazette.
- Amendment of Rule 3- In the Delhi Maintenance and Welfare of Parents and Senior Citizens Rules 2009, in rule 3, in sub-rule (3)-
 - (i) For clause (a), the following clause, shall be substituted, namely:-
 - "(a) The Additional District Magistrate shall be the Presiding Officer of the Maintenance Tribunal of the concerned district and the Deputy Commissioner shall be the Presiding Officer of the Appellate Tribunal, as constituted in the concerned District under his jurisdiction".
 - (ii) In clause (b), for sub-clause (i), the following clause shall be substituted, namely:-
 - "(i) The non-official member should not be less than 35 years of age in case of Maintenance Tribunal and not less than 50 years of age in case of Appellate Tribunal".
 - (iii) In clause (b), for sub-clause (ii), the following sub-clause shall be substituted a namely:- $\frac{1}{2} \left(\frac{1}{2} \right) = \frac{1}{2} \left(\frac{1}{2} \right) \left(\frac{1}{$
 - "(ii) The non-official member should possess a post graduate deg recognized university in case of Maintenance Tribunal and should posse Graduate Degree in Social Work/Sociology/Anthropology/Gerontology in Appellate Tribunal".

(iv) In clause (b), for sub-clause (iii), the following sub-clause shall be sul stituted, namely:-

"(iii) The non-official member should be a person of ability, integrity and standing and should have adequate knowledge and experience of at least 10 years of wed ing with an organization working for the welfare of senior citizens in the area of health, woman empowerment and social welfare in case of Maintenance Tribunal and 15 years of working in case of Appellate Tribunal".

(v) In clause (e), in sub-clause (ii), for the word "Secretary" the word "Director" shall be substituted.
