Sanction of the competent authority i.e. Pr. Secretary (SW) is hereby conveyed for incurring an expenditure Rs.27,80,000/- (Rs. Twenty Seven Lakh Eighty Thousand only/-), for release of 1<sup>st</sup> installment of recurring grant 01 Case mentioned at Serial No. 22, 2<sup>nd</sup> Installment 19 case mentioned at Serial No. 1 to 3, 6 to 21 & 24 and 1<sup>st</sup> and 2<sup>nd</sup> Installment 03 cases mentioned at Serial No. 4, 5 & 23 for the financial year 2014-15 as Grant-In Aid for the under mentioned organizations.

The Sanction has been accorded in exercise of the powers delegated by the Finance Department, Govt. of NCT of Delhi and in consultation with the accounts functionaries of the Department. The expenditure involved on this account would be debit able to the under mentioned Head of Accounts for the year 2014-15 under Demand for Grant No. 08. The expenditure will be incurred under the Major Head "2235 Demand No. A-2(1)(3)(11) under the Plan Scheme of Residential Recreation Center for Old Age Persons for the financial year 2014-15 (Numerical Code 2235 02 104 65 00 42).


The goods/items purchased from this grant shall not be mortgaged or disposed off without obtaining prior sanction/ approval of the Secretary, Department of Social Welfare, Govt. of NCT of Delhi, in writing. These items/goods shall not be utilized for the purposes other than sanctioned/ approved by this Department.

The above recurring Grant is for managing day to day affairs of Recreation Center for Senior Citizens. The organization shall submit the Utilization Certificate for the grant received as per prescribed Performa 19A of GFR- 2005 for the total grant received for the F.Y. 2014-15 (for 1st & 2nd installment of GIA) in respect of receiving of Recurring Grant and Non- Recurring grant received, if any.

If the Government of NCT of Delhi is satisfied that the GIA sanctioned/released is not being used for the approved purposes or some amount of the same is found unutilized during the current financial year the Government of NCT of Delhi can stop the release of further grant and can recover all or partial amount of the GIA through enforcement or as land revenue.

Proper cleanliness in the Recreation Centers be kept and all the required facilities be provided to the beneficiaries according to the norms of the scheme. A board of the organization/project be installed at some conspicuous place indicating that it is being run under GIA from the Department of Social Welfare, Government of NCT of Delhi. No Senior Citizen will be restricted from entering into Senior Citizen Recreation Centre.

Separate account shall be maintained for recreation Centre for Senior Citizens and all receipt bills & vouchers etc. will also be in favor of Recreation Centre. The Organization shall submit a certificate that provisions of the Delhi Grant Rules/Scheme are being adhered by them in their true spirit and sense and the same are not being violated.



It is also certified that the organization mentioned in this sanction are not in receipt of Grant-In-Aid of more than Rs. 5,00,000/- per annum. The pattern of assistance of Grant-In-Aid is approved by the Finance Department, Govt. of NCT of Delhi.
