Manovikas Charitable Society, 60A, Radbeshyam Puri Exm1, Jagatpuri Crossing, Swami Dayanand Marg, Delhi-110051	Assistance under Delhi Grants Rules/Scheme	As per GIA committee observations, the case is not recommended due to below mentioned reasons: The NGO has failed to give detailed justification of large amounts of grants received from Govt./ Non Govt. organizations and under the FCRA.
3.	Aradhana Parents Support Group, D-228 (Basement), Vivek Vihar, Delhi-110095	Assistance under Delhi Grants Rules/Scheme	As per GIA committee observations, the case for non recurring grant is not recommended due to below mentioned reasons: The NGO is running in a rented building since its inception. Any addition and alteration to the existing building has to be done by the owner of the building. The NGO has failed to submit permission letter from owner and futher regarding purchase of motor vehicle, plant and machinery for vocationla training, the NGO has not submitted the specifications and appropriate justification.

Society for the Rehabilitation of physically Handicapped & Mentally Backword	Assistance under Delhi Grants Rules/Scheme	As per GIA committee observations, the case is not recommended due to below mentioned reasons: • The NGO is running through a rented building since its inception. Any addition and alteration to the existing building has to be done by the owner of the building. • No satisfactory justification has been provided for purchase of equipments.
5.	Mata Pita Samman Trust	Assistance under Delhi Grants Rules/Scheme	As per GIA committee observations, the case is not recommended due to to below mentioned reasons: • The NGO is running Recreation Center for Senior Citizens and receiving Grants for the same. • NGOs case for running Day care center under IPOP Scheme is already recommended to GOI. • Despite serving Deficiency Memo, NGO did not provide the satisfactory reply regarding staff and infrastructure.
6.	Cozy Cot Special School, Community Center, JJ Cololny, Sec-7, Dwarks, New Delhi	Assistance under Delhi Grants Rules/Scheme	As per GIA committee observations, the case is not recommended due to to below mentioned reasons: The NGO is running in a leased building of DUSIB since its inception. Any addition and alteration to the existing building has to be done by the owner of the building or with due permission of DUSIB. NGO has not filed clarification regarding purchase of medical, surgical and other special appliances.

Hence the case is not recommended. NGO may apply under the scheme for Recreation Center.
Shri Gyan Gangotri Vikas Sanstha, Rain Basera, Dwarka, Sec-12, New Delhi	New Recreation Centre	As per the observation of DSWO (SW), the NGO has filed proposal for Recreation Center for senior citizen. Hence the case is not recommended. NGO may apply under the scheme for Recreation Center.
9. National Association for Blind Children for Preparatory School for the blind children	Assistance under Delhi Grants Rules/Scheme	As per GIA committee observations, the case is recommended for Rs. 1,51,728/- with the following comments: • ELFA audit report for the 2014-15 indicates unspent balance to the tune of Rs. 2,81,632/-, with the remarks the same amount may be adjusted tin the Grants for the Next financial year or recovered from NGO. • In view of this the GIA committee has curtailed the amount of Grants to Rs. after deducting Rs. 2,81,632/- from the total Grants amount 4,33,360. The Head wise Grant is sanctioned subject to the following terms: a. The organization has to submit their UC and ELFA audit report for the year of 2015-16. b. Sanctioned amount head wise.
