

The Committee observes that "as conveyed by the Ministry of Social Justice & Empowerment, Govt. of India, "under the revised scheme of Prevention of Alcoholism & Substance (Drug) Abuse,, which came into effect from 1.10.2008, Counseling & Awareness Centres have been merged with the Integrated Rehabilitation Centre for Addicts (IRCA's), therefore, funding for maintenance of the Counseling & Awareness Centres would not be possible under the revised scheme". 


