- 4. The utilization certificate should be given for grants/installment released in relevant financial year.
- 5. The previous year proposal file of the concerned NGO may also be taken into account while considering the current proposal.
- 6. While non recommending GIA cases the inspecting officer should clearly mention the reason for during so as per guidelines.

It has been decided in the meeting, the next meeting in this regard will be held on 16/02/2015 at 11.00 AM.
