Schemes & Programmes of Senior Citizens, differently able & vulnerable persons:-

Welfare of Senior Citizens

Government of Delhi has brought out "a policy for senior citizens" The policy considers persons of 60 years and more in age as "Senior Citizens". The policy envisages ensuring welfare of senior citizens and improving quality of their lives. It aims at providing assistance to enable them to cope with the problems of old age. It also proposes affirmative action by the Government Departments in collaboration with civil society for ensuring that the existing public services for senior citizens are made more user friendly and sensitive to the needs of senior citizens. Government of Delhi would also consider having a public education mechanism to prepare people for old age in order to ensure that they are able to grow gracefully and remain financially secure in their later years.

There are a number of schemes implemented by Social Welfare Department for welfare of senior citizens.

1 Financial Assistance to Senior Citizen

(Pension to Senior Citizens)

Old Age Assistance- as per notification by Delhi Govt.- (popularly known as *Old Age Pension*)

Eligibility Criteria

- To persons above 60 years of age.
- Residence of minimum 5 years in Delhi before the date of application
- Annual family income of less than Rs 60,000 from all sources (including rent, interest/dividends on savings & investments, earnings from farm, property sale proceeds etc.) of the applicant & spouse. Applicant has to give a self-declaration regarding income in the appropriate column provided in the application form.
- The applicant should have an Aadhaar number or should have enrolled with UIDAI for Aadhaar number
- The applicant should have a 'singly-operated' account in any Bank in National Capital Territory of Delhi only, for receiving the payment through electronic clearing system (ECS) or through Aadhaar Payment Bridge System (APBS)

 Must not be receiving any pension/ financial assistance from Central Govt/ State Govt/ other governmental local bodies or any other source, including spouse, for this purpose.

Application process

- a) Application forms available from District Social Welfare Office/ Hqrs/ website/MLA offices
- b) Application Form as well as photocopies of all documents to be self-attested.
- c) Applicant to apply in person at District Social Welfare Office with following documents-
- Age proof
- Residence proof
- Aadhaar number/ Enrollment number
- Bank a/c number (Single a/c)
- In case of SC/ST applicants in the age bracket 60-69 years, caste certificate in the name of the applicant issued by Competent Authority has to be submitted. In case of Minority applicants within 60-69 years, self-declaration of the religion of the person has to be submitted.
- One passport size photo of the applicant.

Recommendation of area MP/MLA or a Gazetted Officer is not mandatory. Self-attested forms are also acceptable.

Quantum of Assistance

- Rs 1000 p.m. for 60-69 years, with additional Rs. 500 p.m. to SC/ST/Minority community beneficiaries
- Rs 1500 p.m. for 70 plus age group.

Mode of payment-

The assistance is remitted monthly to the bank account of the beneficiary through APBS as per the Aadhaar number of the beneficiary or through ECS of RBI. The details regarding allocation of fund, expenditure incurred and beneficiaries covered under the plan scheme "Financial Assistance to Senior Citizen(Old Age Pension)" in Delhi during the last Six years from 2010-11 to 2015-16 is presented in the following statement:

2. Old Age Homes

Under the Plan Scheme- Welfare Programme for old aged persons , the Deptt. of Social Welfare is running two old age homes:

- 1. Home for Aged and infirm persons, Bindapur, Pocket-IV, New Delhi-110059
- 2. Home for Senior Citizens, ,Sewa Sadan Complex Lampur, Delhi-110040.

<u>Admission Procedure:</u> Admission in Old Age Home is given on applying in the prescribed form either in the office of Old Age Home itself or in the office of the respective District Social Welfare Officer or in the office of Dy. Director (Social Security) at Headquarter. On the recommendation of the Admission Committee after completion of all the formalities as per rules residential facility is being provided.

<u>Eligibility Criteria:</u> Admission in the institution is open to any senior citizen (resident of Delhi) in the age group of 60 years and above who is not suffering from any communicable disease having no shelter or income, may apply for admission in Old Age Home.

Facilities:

- Free boarding/lodging at the state run Old Age Homes for free seats.
- Medical care & Counseling.
- Recreational facilities and Rehabilitation programme.

The Department of Social welfare, GNCT of Delhi has initiated construction of 10 more Old age homes in different areas of Delhi i.e. at Chitranjan Park, Rohini, Kanti Nagar, Paschim Vihar, geeta colony, Wazirpur and Chattarpur, Janakpuri, Sarita Vihar and Vasant Kunj to cater the needs and requirement of Old Age persons.

3. Recreation Facilities.

Under the Plan Scheme – Residential Recreation Centre for Senior Citizen, financial grant is provided for running of Recreation Centre for senior citizens all over Delhi.

<u>Aims and Objective:</u> The aim of setting the Recreation center is to provide facilities for relaxation, avenues of social and cultural activities for their leisure which will help the senior citizens to integrate them with their families.

Eligibility

- Senior Citizen organizations/RWAs and those NGOs who are exclusively working on the issues related to the Welfare of the Senior Citizens.
- The Organization should have at least three year old Registration under Societies Registration Act which can be relaxed in case of Organization of Senior Citizens themselves / the societies Registered with Registrar of Cooperative Societies are also eligible.
- It should have at least 50 registered members with it.
- Under the Scheme Non-Recurring Grant to the tune of Rs. 75,000/- (one time grant) and Recurring Grant of Rs.20,000/- P.M is provided to Organizations running Recreation Centers. The Organizations which do not have any space are given a monthly grant of Rs. 10,000/- for carrying out Sr. Citizens Recreational activities.

At present 94 running Recreation centre are getting grant from the Delhi Govt. During the Financial year 2015-16 Rs 1,75,94,073/- has been released out of the total

budget of Rs 1,78,00,000/- as Grant-in-Aid to the 94 running recreation centers for senior citizens.

4. Maintenance Tribunal

The Government of Delhi has notified and set up 11 Maintenance Tribunal in all eleven Districts of Delhi to exercise the powers and discharge the functions conferred under the Maintenance and Welfare of Parents and Senior Citizens Act, 2007.

Under this Act any senior Citizen or parent who is unable to maintain himself or who's children are not maintaining him/her from his own earning or out of property owned by him, shall be entitled to make an application against their children for Maintenance.

Maintenance Tribunal in each district is headed by A.D.M.s as the Presiding Officer/ Chairperson along with two Non-Official Members one of whom is female.

5. **Appellate Tribunal**

The Government of Delhi has notified and set up 11 Appellate Tribunal in all eleven Districts of Delhi to exercise the powers and discharge the functions conferred under the Maintenance and Welfare of Parents and Senior Citizens Act, 2007.

A Senior citizen can make appeal to following appellate tribunals against the decision of maintenance tribunal.

Appellate Tribunal in each district is headed by Dy. Commissioners (Revenue) as the Chairpersons along with two Non-Official Members, one of whom is a female

The total number of cases filed and disposed off by the Maintenance Tribunals in all 11 District of Delhi during the period 2014 and 2015 is as under:-

6. Welfare of Differently Able Persons

The Department of Social Welfare is the Nodal Department for the welfare of persons with disabilities. It deals with implementation of Persons with Disabilities Act, 1995. Various schemes and programmes are being run for the well being of persons with disabilities. For the welfare of persons with disabilities department is running:-

- 05 Schools for Deaf and dumb with 1306 students.
- 06 homes for mentally challenged persons with 1083 residents.
- 01 School for mentally challenged children with 54 students.
- 01 Hostel for school and college going blind boys with 226 students.
- 01 Schools for blind with 130 students.
- 01 Training Cum Production Center with 5 workers who are PwD.
- 01 Sheltered Workshop for Physically Handicapped with 04 workers who are PwD.

Department organizes General Disability Camps under National Programme for Rehabilitation of Persons with Disabilities (NPRPD) scheme every year in various districts of Delhi in collaboration with various Departments. in order to provide disability certificate, DTC bus pass, distribution of financial assistance forms, registration of disabled children in Govt. hospitals, Identity cards from SDM office, distribution of aids and appliances etc to Persons with Disabilities under single roof.

Earlier Special Disability Camps were organized by Deptt in collaboration with NGO namely Bhagwan Mahavir Viklang Sahara Samiti. But the same were discontinued from FY 2014-15 as per the decision taken in a meeting held in the chamber of Jt. Director(SW) on 14/07/2014.

In the current financial year 2016-17 Deptt. has proposed to organize 20 general disability camp. The details regarding allocation of fund, expenditure incurred and beneficiaries covered in the campsi during the last five years from 2012-13 to 2015-16 is presented in the following Statement

7. Financial Assistance to Persons with Special Needs- as per notification by Delhi Government (popularly known as *Disability Pension*)

Eligibility Criteria-

- 1. To persons between the age of 0-59 years
- 2. Disability 40% or more to persons with blindness, low vision, locomotor disability, hearing impaired, leprosy cured, cerebral palsy, autism, mental retardation or mental illness
- 3. Residence of minimum 5 years in Delhi before the date of application
- 4. Annual family income of less than Rs 75,000 p.a. from all sources (including rent, interest on savings et cetera). Here "Family" means parents or if the parent(s) are not alive then legal guardian in case of the minor, unmarried, unemployed disabled person(s). In case of married disabled persons, it means wife /husband and minor or disabled adult children solely dependent on him/her. Applicant will need to give a self-declaration regarding income in the appropriate column provided in the application form.
- 5. The applicant should have an Aadhaar number or should have enrolled with UIDAI for Aadhaar number
- 6. Must not be receiving any pension/ financial assistance from Central Govt/ State Govt./ other governmental local bodies or any other source for this purpose

Application Form as well as photocopies of all documents to be self-attested.

Applicant to apply in person at District Social Welfare Office with following documents-

Assistance is remitted monthly to the beneficiaries' bank account through APBS as per the Aadhaar number of the beneficiary or through ECS of RBI

8. **DELHI FAMILY BENEFIT SCHEME** - as per notification by Delhi Govt. **NATIONAL FAMILY BENEFIT SCHEME** (NFBS)- as per GoI

The scheme provides for one-time assistance to the family members of deceased primary bread winner (male/female) of a household who are without adequate means of subsistence, to help tide them over immediate financial difficulties.

Eligibility Criteria

1. Age of the deceased should be between 18 to 60 years, i.e. death of the bread earner has occurred while he/she was in the age group 18-60 years. "Bread

- earner" is defined as the member of the household whose earnings contributed the largest proportion to the total household income.
- 2. Resident of Delhi for more than 5 years before the date of application
- 3. Family income of the applicant should not be more than Rs 60,000/ per annum. Applicant will need to give a self-declaration regarding income in the appropriate column provided in the application form.
- 4. The applicant should have an Aadhaar number or should have enrolled with UIDAI for Aadhaar number
- 5. The applicant should have a 'singly-operated' account in any Bank in National Capital Territory of Delhi only, for receiving the payment through electronic clearing system (ECS) or through Aadhaar Payment bridge System (APBS)

9. WELFARE OF LEPROSY AFFECTED PERSONS

A Rehabilitation Center for Leprosy [RCL] affected person was established during the year 1980-81. At present Social Welfare Department is paying Rs 1800/- per month to RCL beneficiaries as financial assistance. Most of the beneficiaries are residing in different areas of Delhi such as Tahirpur [Trans Yamuna], R.K.Puram, Sri Niwas Puri & Patel Nagar etc. The major colony of Leprosy affected persons is Tahirpur where Shelter workshop & Training cum Production center are located. In these centers, Department provides production work facilities to enable leprosy affected persons to stand on their own feet and to make them economically independent. In these centers, department provides training facilities in handloom weaving, shoe-making, chalk making, candle making etc.

10. New home for mentally challenged persons at Mamurpur Narela.

The aim of the scheme is to provide residential care to the mentally retarded for their education, training guidance, medical care and rehabilitation. A home on vacant land measuring 7.69 acres at Narela is proposed to build. The construction of boundary wall and leveling work of land has been completed. The new home for mentally challenged children and adults will be having a capacity of 600 inmates (approx).

12. BEGGARS

There are 11 institutions for the beggars in various parts of Delhi, which look after beggars as and when beggars are sent to these homes under the Bombay Prevention of Begging Act, 1959 as extended to UT of Delhi. In addition to one regular Beggars Court , two mobile Beggars courts have been started in 2009. A table regarding details of anti begging operation & trial by beggars is given as under:-

9. Welfare of Senior Citizens

9.1 Government of Delhi has brought out "a policy for senior citizens". The policy considers persons of 60 years and more in age as "Senior Citizens". The policy envisages ensuring welfare of senior citizens and improving quality of their lives. It aims at providing assistance to enable them to cope with the problems of old age. It also proposes affirmative action by the Government Departments in collaboration with civil society for ensuring that the existing public services for senior citizens are made more user friendly and sensitive to the needs of senior citizens. Government of Delhi would also consider having a public education mechanism to prepare people for old age in order to ensure that they are able to grow gracefully and remain financially secure in their later years. There are a number of schemes being implemented by Social Welfare Department for welfare of senior citizens.

9.2 Financial Assistance to Senior Citizen

This scheme is being implemented by the Department of Social Welfare. Under this scheme, assistance is remitted on quarterly basis in the savings accounts of the beneficiaries maintained in the bank, through Aadhaar Enabled Payment System (AEPS) as per the Aadhaar number of the beneficiary or through Electronic Clearing System (ECS) of RBI. The persons, who are resident of Delhi for minimum five years with proof, age of 60 years and above and having family income less than Rs. 60,000/- per annum are eligible. The income does not include the income of independent sons and daughters. Area MLA/MP/Gazetted Officer may recommend the application. All supporting documents to be self-attested by the applicant. The applicant must have a valid ID proof as listed in the notification. The quantum of financial assistance to senior citizens of 70 years and above is Rs. 1500/- per month, whereas for those between 60-69 years, it is Rs. 1000/- per month. Additional assistance of

Rs. 500/- per month is provided to the beneficiaries of SC/ST/Minorities category on production of relevant documents. The total number of beneficiaries admissible under the scheme has been enhanced by 40000 cases and now the ceiling on total number of cases is 4.3 lakh. The details regarding allocation of fund, expenditure incurred and beneficiaries covered under the plan scheme "Financial Assistance to Senior Citizen(Old Age Pension)" in Delhi during the last five years from 2010-11 to 2014-15 is presented in Statement 17.1

9.3 Old Age Homes

The Govt has established two Old Age Homes-One at Bindapur, Pocket-IV, New Delhi -110059 being run by the Department of Social Welfare and another at Lampur, Sewa Sadan Complex, Lampur, Delhi-110040, being run in collaboration with NGOs namely Delhi brotherhood Society under PPP mode.

The following service provided at the Old Age Homes

- 1 Free boarding/lodging at the state run Old Age Homes
- 2 Medical care & Counselling.
- 3 Recreational facilities and rehabilitation programme.
 Eligibility Criteria :- Admission in the institution is open to destitute Old and Infirm
 Person:-

Who are in the age group of 60 years and above.

Who have none to support or maintain them.

Who are not suffering from any infectious/communicable disease.

Who are residents of Union Territory of Delhi.

• Beside these Lands have been acquired /possession taken for construction of new Old Age Homes at 1.Chitranjan Park, 2.Kanti Nagar, 3. Vasant Kunj 4. Rohini. 5. Wazirpur, 6. Paschim Vihar, 7. Chatarpur 8 Geeta Colony, 9. Sarita Vihar and 10. Janakpuri. This is an effort to setup Old Age Home in each district.

9.4 Recreation Centers for senior Citizens

The scheme of recreation centre is operational in Delhi it provides an avenue for the well being and over all development of the elderly citizens in Delhi The aim of recreation centre for aged person is to provide facilities for relaxation, avenues of Social interaction for their leisure time. There are 94 running Recreation Center getting grant for the financial year 2015-16 and propose to finance 140 recreation centres for Senior citizens during the year 2016-17.

9.5 Maintenance Tribunal and Appellate Tribunal

The Government of Delhi has notified and set up eleven Maintenance Tribunals and Appellate Tribunals in all eleven districts of Delhi to exercise the powers and discharge the functions conferred under the Maintenance and welfare of parents and Senior Citizen Act.2007 Maintenance Tribunals in each district is headed by A.D.M.s as the Presiding Officers / Chairperson along with two Non-official Members one of whom is female . Appellate Tribunal in each district is headed by Dy. Commissioners (Revenue) as the Chairpersons along with two Non-official Members one of whom is a female

The Deputy Commissioner under Rule 21 have been empowered to ensure life and property of senior citizen, oversee the work of Maintenance and Appellate Tribunals, monitoring of old age homes, liasioning /coordination issues, awareness generation, sensitization etc.

Action Plan for the protection of life and property of senior citizen drawn up under Rule 22 , wherein the police officer is required to take action in case of complaint.

10. Welfare of Differently Abled Persons

10.1 The Department of Social Welfare is running 5 schools for deaf with + hostel having ____ students, 3 Training cum Production Centres 2 Sheltered Workshop for differently abled persons, 1 Hostel for the College going blind boys having students and 1 school for the visually handicapped with ___ students Six homes and 1 school for mentally challenged children with ____ students respectively. Further, Social Welfare Department has constructed a primary school for deaf at Nehru Vihar for providing educational facilities to deaf children of the school going age in case of complaint.

10.2 General and Special Disability Camps :- Under the Scheme "National Programme for Rehabilitation of Person with disabilities" two types of camps i. e. General Disability Camps and special Disability Camps were organized by Department of Social Welfare in all districts of Delhi. General Disability Camps will be organized in coordination with other govt. agencies in every district in which persons with disabilities are facilitated with the facility of disability certificate, DTC Passes, ID Card by the office of Dy. Commissioner, Registration in Integrated School Railway Concession Pass, Services for Autism & Cerebral palsy, Aid and Appliances, issue of forms of different schemes of FAS

During 2015-16 14 general disability camps were organized which benefitted approximately 5000 Persons with Disabilities. For the first time Department had organized general disability camp for persons with disabilities having Mental Retardation (Challenged)/Mental Illness, Neurological Disorder, Cerebral Palsy etc. in district office (West) at Janakpuri Super Speciality Hospital, Janakpuri. In the CFY 30 camps will be organized and for that Rs.50.00 lacs has been allocated

Here "Family" means parents or if the parent(s) are not alive then legal guardian in case of the minor, unmarried, unemployed disabled person(s). In case of married disabled persons, it means wife /husband and minor or disabled adult children solely dependent on him/her. Mentally challenged and mentally ill persons have also been included in the scheme for the benefits. The assistance is remitted on quarterly basis in the savings accounts of the beneficiaries maintained in the bank, through Aadhaar

Enabled Payment System (AEPS) as per the Aadhaar number of the beneficiary or through Electronic Clearing System (ECS) of RBI.

11. National Family Benefit Scheme

The objective of the scheme is to provide one-time assistance to poor households in the event of the death of the breadwinner (male/female). 'Bread winner' is defined as the member of the household whose earnings contributed the largest proportion to the total household income. Amount of benefit is Rs. 10,000/-. The applicant should have residence proof of minimum 5 years stay in Delhi before the date of application and the age of the deceased should be between 18 to 60 years, i.e. death of the bread winner has occurred while he/she was in the age group 18-60 years. Family income of the applicant should not be more than Rs 60,000/- per annum.

13. WELFARE OF LEPROSY AFFECTED PERSONS

A Rehabilitation Center for Leprosy [RCL] affected person was established during the year 1980-81. At present Social Welfare Department is paying Rs 1800/- per month to RCL beneficiaries as financial assistance. Most of the beneficiaries are residing in different areas of Delhi such as Tahirpur [Trans Yamuna], R.K.Puram, Sri Niwas Puri & Patel Nagar etc. The major colony of Leprosy affected persons is Tahirpur where Shelter workshop & Training cum Production center are located. In these centers, Department provides production work facilities to enable leprosy affected persons to stand on their own feet and to make them economically independent. In these centers, department provides training facilities in handloom weaving, shoe-making, chalk making, candle making etc.

New home for mentally challenged persons at Mamurpur Narela.

The aim of the scheme is to provide residential care to the mentally retarded for their education, training guidance, medical care and rehabilitation. A home on vacant land measuring 7.69 acres at Narela is proposed to build. The construction of boundary wall and levelling work of land has been completed. The new home for mentally challenged children and adults will be having a capacity of 600 inmates (approx).

12. BEGGARS

There are 11 institutions for the beggars in various parts of Delhi, which look after beggars as and when beggars are sent to these homes under the Bombay Prevention of Begging Act, 1959 as extended to UT of Delhi. In addition to one regular Beggars Court, two mobile Beggars courts have been started in 2009.A table regarding details of anti begging operation & trial by beggars is given as under:-

Person with Disability Welfare Branch

Economic survey of Delhi 2016-17

The Department of Social Welfare is the Nodal Department for the welfare of persons with disabilities. It deals with implementation of Persons with Disabilities Act, 1995. Various schemes and programmes are being run for the well being of persons with disabilities. For the welfare of persons with disabilities department is running:-

• 05 Schools for Deaf and dumb with 1306 students.

- 06 homes for mentally challenged persons with 1083 residents.
- 01 School for mentally challenged children with 54 students.
- 01 Hostel for school and college going blind boys with 226 students.
- 01 Schools for blind with 130 students.
- 01 Training Cum Production Center with 5 workers who are PwD.
- 01 Sheltered Workshop for Physically Handicapped with 04 workers who are PwD.

National Programme for Rehabilitation of Persons with Disabilities (NPRPD)

Deptt. organizes General Disability Camps under National Programme for Rehabilitation of Persons with Disabilities (NPRPD) scheme every year in various districts of Delhi in collaboration with various Deptts. in order to provide disability certificate, DTC bus pass, distribution of financial assistance forms, registration of disabled children in Govt. hospitals, Identity cards from SDM office, distribution of aids and appliances etc to Persons with Disabilities under single roof.

Earlier Special Disability Camps were organized by Deptt in collaboration with NGO namely Bhagwan Mahavir Viklang Sahara Samiti. But the same were discontinued from FY 2014-15 as per the decision taken in a meeting held in the chamber of Jt. Director(SW) on 14/07/2014.

In the current financial year 2016-17 Deptt. has proposed to organize 20 general disability camp.
