The issue of barrier free environment was taken up in last State Executive Meeting and with PWD officials to ensure that appropriate steps would be taken up to remove difficulties to make buildings accessible for PwDs. Office of the Commissioner Disabilities, GNCTD is conducting Accessibility Audit /Survey of different Govt. buildings / Schools / Establishments to ensure high accessibility standards for citizens with disabilities. The Accessibility Audit is under process. The Office of the Commissioner Disabilities is also taking up the matter of implementation of the audit report with the individual Department.
ix.	Please provide the details of monitoring and evaluation of the impact of policies and programmes designed for achieving equality and full participation of persons with disabilities.	Matters pertain to Commissioner Disabilities, GNCTD as per Section 61& 62 of PwD Act, 1995.
x.	Whether SEC has been constituted and is functional? If not, the reason thereof and steps taken for its constitution or make it functional?	Yes, the last SEC was constituted on dt. 19/01/2012 for three years. Reconstitution of SEC is under process.
