62. Empowering the Disabled.

(A) We are committed to protecting the rights of Persons with Disabilities (PwDs), and hope to make Delhi an example for the rest of India.

Existing Status : Presently subsistence allowance to Persons with disabilities with more than 40% disability in the age group of 0-59 years is being paid Rs.1500/- p.m. having annual income of less than Rs.75000/- and five years residence in Delhi.

Action Plan :

- As per the present rules, at the age of 60 years persons with disabilities are required to apply under Old Age Financial Assistance Scheme. This leads to loss of Rs.500/- p.m. to the persons with disabilities.
- There is a proposal to amend the scheme to increase the upper age limit to until death so that new applicants apply in this scheme only.

The Department is also running following schools & Homes for differently abled children.

- Five school for hearing impaired
- One school for visually challenged.
- One school for mentally challenged.
- Pipeline: Construction of school for mentally challenged children at Usmanpur. Land for this school has been allotted and possession of the same has been taken over by the Deptt. to be completed within next 18 months.
- Homes for mentally challenged children and adults :-
 - Asha Kiran Complex for mentally challenged children and adults at Avantika, Rohini, Delhi.
 - Asha Deep Home for mentally challenged male (adult) at Narela
 - Asha Jyoti Home for mentally challenged female (adult) at Nirmal Chhaya Complex, Jail Road, New Delhi
- Pipeline : Three new homes at the following locations for mentally challenged are proposed.
 - Narela for 600 inmates in a 10 acre complex,
 - Nirmal Chhaya complex for 50 residents in an area of 900 sq mts
 - Vasant kunj for 100 residents in an area of 2092 Sq Mts
 - Five Half way/ Long stay Homes for mentally ill treated patient.
 - Buildings for three half way/ long stay homes have been completed.
 - Two buildings are going to be completed shortly.
 - The Half way Homes are proposed to be run on society mode.
 - The process for formation of society has been taken up.

(B) AAP will ensure implementation of the 3% reservation for persons with disability.

Appropriate instructions in this regard are required to be issued by the Services Department. Letters have already been sent to various Departments for appropriate action.

- (C) **We will strive to make education truly inclusive by hiring special educators in government schools.**

To be implemented by Education Department. Letter has already been sent to the Department for appropriate action.

- (D) **AAP will help children with disability get admission into schools and colleges and ensure financial support to institutions working especially for their needs.**

- The Department of Social Welfare is providing grant in aid to NGOs working in the field of disability and also recommending cases for grant in aid to the Government of India.
- 07 NGOs have been provided grant-in aid under Delhi Grant Scheme in the year 2014-15.
- A Total of Rs 38,60,427/- (thirty eight lakhs sixty thousand four hundred and twenty seven) was provided. Grants ranging from Rs four lakhs to Rs nine lakhs for various projects i.e. (i) non residential school for handicapped; (ii) treatment and education of physically handicapped; (iii) special school for mentally challenged children; (iv) hostel for visually challenged; (v) preparatory school for the blind; (vi) craft production centre cum training institute for the hearing impaired; and (vii) comprehensive rehabilitation centre for the mentally challenged
- Under Scheme of Assistance to Persons with disabilities for Purchase/ fitting of Aids and Appliances ADIP Scheme 2 NGOs has been recommended for grant in aid by the Government of India for the year 2014-15.
