
**CORRIGENDUM**

The committee has considered the entire question and unanimously reached to the conclusion that in view of the clarification sought by the Bidder the tender documents needs to be amended by way of corrigendum. The necessary amendment recommended by the committee are as under:-

S. No.	Question	Answer
a)	How to apply for the categories of posts i.e One category in one package or the three category in one package?	<b>The Intending bidders can bid/participate in e-tender/tender for any one to all the categories for providing the manpower and services.</b> The category detail is available in this tender document. The bidder shall bid for all posts of any one or all the three categories, if the bidder does not want to bid for any category they will quote as "0" (zero) for all the posts of that category. It is further clarified that one EMD is to be deposited for all or any one or two of the category for which the bidder want to participate alongwith covering letter specifying the category for which the EMD stands for.
b)	How to calculate the 30% of the estimate value of each category of work.	<b>Tender document is being amended by issuing corrigendum in this regard.</b>
c)	How to submit the full details of his ownership and control? i.e in point 3.3 for the tender document.	<b>Supporting document for ownership is as under:-</b> <b>In the case of –</b> <b>a) Proprietorship firm:- Bank Certificate</b> <b>b) Partnership Firm:- Partnership Deed</b> <b>c) Company:- Registration/MOA.</b> <b>d) Joint Venture/Consortium:- An Agreement.</b>
d)	Regarding Price Bid Annexure-XI how the decision will be taken for L-1? i.e. Basic Pay + Grade Pay + DA etc.	<b>Will be based on total of Price Bid of each category independently.</b>
e)	Point No.8.3.3 regarding EPF contribution @ 10%.	<b>Tender document is being amended by issuing corrigendum in this regard. The EPF contribution is to be as per rules in force.</b>
f)	Point No.9.1.2.(i) Self attested copy of License under Manpower supply (Regulation) Act.	<b>License under Labour Act.</b>

The point No. 45 under the heading **TERMS AND CONDITIONS OF THE CONTRACT the last sentence mentioned as:-**

**"Hospital will be at liberty to get anybody re-examined in case of any suspicion."**

Shall be read as:-

**"Deptt. of Social Welfare, will be at liberty to get anybody re-examined in case of any suspicion."**

In the Annexure -11 regarding **PRICE BID FOR MANPOWER SERVICES** for the category-I, category-II and category-III the heading of column No. 4 is **mentioned as:-**

**"The Colum No. 6 of Annexure-XI (category I, II &III) regarding EPF + EDLI + Administration charges shall be calculated at @ as mentioned below:-**
