As per the decision of the tender Committee in the meeting held on 02.09.2014, for giving one more but last opportunity to M/s Pioneer World on its request dated 29.08.2014 in regard of allowing the firm to submit the requisite legiable documents upto 11.09.2014. The tender committee decided in the above said meeting that further no extension of time will be given in any case as the sufficient time has already been given to the bidder and also decided that in case of non submission of requisite documents upto 11.09.2014, the EMD deposited by the bidder M/s Pioneer World will stand forfeited.

It was informed to the tender committee members that minutes of meeting dated 02.09.2014 was uploaded on the website of Social Welfare Department on 03.09.2014. Further a letter to M/s Pioneer World was posted on 03<sup>rd</sup> September, 2014 for intimation of tender committee decision.

Thereafter, a letter received from M/s Pioneer World on 11.09.2014 was placed before the tender committee in which the firm had shown its inability to deposit the requisite documents within time as settled by the firm earlier in its letter dated 28.08.2014 and also requested to tender committee to take decision as per terms & conditions laid down in the tender document.

The Tender Committee observed the request of M/s Pioneer World and it was decided to inform to M/s Pioneer world that clause 40 incorporated in the Head "instruction to the bidder" was the condition meant for filing of e-tender on-line floated on 04.07.2014.

As the documents uploaded by the bidder sought at Instruction to the bidder(Submission of bid) at Sr. No. 39 of e-tender floated on 04.07.2014 were not legible and the requisite legible photo-copies of uploaded documents were needed for technical evaluation of the bidder. But M/s Pioneer world, had not submitted the legible photo-copies of uploaded documents inspite of number of opportunity were given to the bidder from this office vide letter dated 07.08.2014, 25.08.2014 & 03.09.2014.

Keeping in view of the above, the tender Committee recommend to forfeit the bid security/EMD deposited by M/s Pioneer World as per instruction to the bidders at Sr.No. 5 clause (c) incorporated in tender document due to non submission of the legible photo copies of uploaded documents.

The tender committee also recommend that M/s Pioneer World will not be allowed to participate in any of tender invited from Social Welfare Department for further period of 02 years.

The tender committee further recommend for cancellation of etender called on 04.07.2014 for providing 08 small cars as there is only one bidder is left i.e., M/s Mukhija Travel, which is non-competitive in absence of any other bidder and also recommend for floating of fresh tender for hiring of 08 small cars.
