### TERMS AND CONDITIONS:

- The work consists of supply, Installation, testing, commissioning and maintenance of CCTV camera with voice recorder system in accordance with the technical specifications, terms and conditions mentioned in tender documents.
- Before quoting the rate, the prospective bidder may visit the District offices where CCTV cameras with voice recorder are to be installed as per address and telephone number of the District offices in tender document.
- Department of Social Welfare, GNCTD shall hold a pre-bid meeting with prospective bidders on the date and time as mentioned in the schedule in the chamber of Chairperson/DD (FAS), Delhi Gate, Delhi. Department of Social Welfare, GNCTD shall not be responsible for ensuring that the bidders' queries have been received by them. Any request for clarifications after the indicated date and time may not be entertained by the Department of Social Welfare, GNCTD.
- The specification of the equipment supplied should be equivalent or higher than the specifications mentioned in the tender document.
- The cameras installed should cover at least 30 meters of clear view.
- 6 Conditional/Unsolicited tenders shall not be considered.
- 7 If required, the bidder can be called for an on-site demo to evaluate the quality of recording and video file out puts of the quoted CCTV equipment before it is approved.
- The prices quoted in the Financial Bid should be inclusive of all taxes and includes equipment, installation charges, materials, labour, tools, appropriate cabling and necessary management for completion of the work. The vendor should quote the prices for providing complete solution. After placing the order, department will not pay any extra amount which is not mentioned in the financial bid.
- 9 Any loss or damage or theft will be borne by the vendor until installment of CCTV cameras.
- 10. Successful bidder should deposit, 10% of the total cost of contract as performance guarantee in the form of FDR/Bank Guarantee in favour of Director, Department of Social Welfare, GNCTD payable at Delhi and issued from any of the Nationalized/Scheduled/ Commercial Bank located in Delhi/NCR. The performance guarantee should be valid for a period of 60 days beyond the date of completion of all contractual obligations.
- 11. The successful bidder shall enter into a contract, with Department of Social Welfare, incorporating all clauses of the tender document.

- 13. The L1 shall be decided as per the Grand Total in the Financial Bid.
- 14. While every effort has been made to provide comprehensive and accurate background information and requirements and specifications, Bidders must form their own conclusions about the solution needed to meet the requirements. All information supplied by Bidders may be treated as contractually binding on the Bidders, on successful award of the assignment by the Department of Social Welfare, GNCTD on the basis of this tender document.
- 15. The Bidder has to submit its bid only through e-Procurement platform of GNCTD. No other mode shall be entertained. Only EMD should be submitted physically in Department of Social Welfare, GNCTD. Bids must be submitted on-line through e-portal https://govtprocurement.delhi.gov.in on or before the stipulated time mentioned in the tender document. Department does not take any responsibility for the delay caused due to non-availability of internet connection or network traffic jam for on-line bids. - In order to participate in e-Procurement platform the vendor should register (if not already registered) on e-Procurement platform of GNCTD after paying the registration fee, at Vikas Bhawan-II, Near Metcalf House, Delhi.
- 16. Bidders are advised to study all instructions, forms, terms, requirements and other information in the tender document carefully. Submission of the bid shall be deemed to have been done after careful study and examination of the RFP document with full understanding of its implications
- 17. The successful vendor should complete the work within 30 days from the receipt of order.
- 18. After successful installation and testing, vendor has to impart the training without any cost to the officers/officials of the department to operate the equipment.
- 19. The corrigendum/addendum/clarification (if any) will be posted on e-Procurement website. Any such corrigendum shall be deemed to be incorporated into this tender document.
- 20. This document does not constitute an offer by Department of Social Welfare, GNCTD. The bidder's participation in this process may result Department of Social Welfare, GNCTD selecting the bidder to engage towards execution of the contract.
- 21. The entire CCTV system supplied & installed should be under on-site warranty for one year as specified against all types of defects from the date of handing over of the product to the department. Any defects found in the product/sub-product within the warranty period shall be rectified / replaced by the Vendor free of cost. During this period of warranty, servicing at quarterly interval or earlier without any additional cost besides attending to call back services in case of break down shall be carried out free-of-cost. This includes replacement of all parts and spare parts and any number of break down call.
- 22. After lapse of warranty of one year, CCTV camera with voice recorder will be on two year maintenance and the bidders should quote the rate in Price bid. Maintenance charges

will be paid to the successful bidder on quarterly basis.

- 23. Please note that department will apply penalty as below in case of discrepancy in services under warranty period:
- On receiving complaint about equipment/ services, the Vendor will promptly respond and repair/ replace or provide required services within 72 hours, failing which, penalty shall be levied @ Rs. 500/-per day.
- 24. The Vendor should submit the bill alongwith installation and commissioning report after completion of work to the Deputy Director (CTB), DSW, Delhi Gate, Delhi . Advance payment is not permissible. However, the payment shall be made within a month from the date of successful installation/commissioning report.
- 25. The Director Social Welfare Department, Delhi Gate, Delhi reserves the right to reject any or all tenders at any time without assigning any reason.
- 26. The Director Social Welfare Department, Delhi Gate, Delhi taking note of overall facts and circumstances can change, add and relax any of the terms and conditions of this tender notice.
